Cookies and Related Technologies

We, VD Law Group, use cookies to offer you the best experience during your journey on our website.

Cookies are small text files that are placed and stored on your device when you visit our website.

Depending on their purpose, cookies can be classified into several categories, such as:

Technical cookies which are used to run and protect our website while others are used to make it more efficiently. **Analytic and advertising cookies** which enable us to analyses your activity on our website so that we can serve you better in the future. **Non-tracking cookies** which are used to store your decisions in terms of your ad consent and opt-out choices.

Most cookies contain a unique identifier called a cookie ID (a string of characters that websites and servers associate with the browser on which the cookie is stored). It allows our websites and servers to distinguish the browser from other browsers that store different cookies, and to recognize each browser by its unique cookie ID.

If we do collect personal data through our website, we'll be upfront about this. We'll make it clear when we collect personal information, and we'll explain what we intend to do with it.

How do I change my cookie settings?

You can adjust the available sliders to 'On' or 'Off', then clicking 'Save and close'. You may need to refresh your page for your settings to take effect. Alternatively, most web browsers allow some control of most cookies through the browser settings.
